The naturally filtered, high-quality water from Carmeuse's quarries now serves as a reliable and cost-effective source for the county. A lease-to-own option enables Frederick Water to acquire the quarries after mining concludes, ensuring long-term water security for the region.

This initiative supports the county's growing water demands in an environmentally responsible manner. It stands as a model of mutual benefit—for Carmeuse, for Frederick Water, and for the broader community.
